- **COLLECT:** Winner will be chosen within **5 days based on number of shares and the layout/comments**, We will **notify them via social media DM**, and they will have **10 days to claim their prize**.

DETAILED VERSION:

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.
